RAP NIGERIA – Review Completion Course

The first ever Reviews for Africa Programme to be held in Nigeria began in 2009 when the first phase of the programme (a two week protocol development workshop) was held from 19th-30th October. Since then, in the second phase of RAP Nigeria, the participants have been working individually on their reviews at their respective home institutions with support and mentorship. The reviewers converged once again at the National Hospital Abuja for the third and final phase of the Programme (a review completion course) from July 26 to August 6, 2010. The Reviews for Africa Programme (RAP) was designed by the South African Cochrane Centre to train African Scientists in Research Synthesis and assist them initiate and prepare Cochrane Reviews.

Five participants were in attendance – namely: Ifeanyi Ezedunukwe, Yusuf Misau, Bappa Adamu, Chizoma Ndikom and Segun Bello. However, four of these participants were there right from the first phase of RAP Nigeria. The fifth original participant had his protocol undergoing peer reviewing at the time and so was unable to attend. Segun Bello, a senior registrar in the Department of Community Medicine, University of Calabar Teaching Hospital was therefore invited to attend. Segun is conducting a review on *Routine vitamin A supplementation for the prevention of blindness due to measles infection in Children* with the Acute Respiratory Infections Cochrane Review Group. He is also a co-author of a registered title: *Hand hygiene practices for prevention of nosocomial infection*.

Most of the faculty members who facilitated the sessions during the protocol development workshop were present: Prof. Martin Meremikwu; Dr. Oluseyi Oniyangi; Dr. Emeka Nwachukwu; Ms. Chioma Oringanje; and Dr. Emmanuel Effa. In addition, they were joined, Dr. Tamara Kredo, a staff of the South African Cochrane Centre (SACC). Tamara has a special interest in evidence-based healthcare practice and policy and completed a systematic review assessing the value of antiretroviral therapeutic drug monitoring in 2008.

The review completion course was a two-week programme designed to:

1. Expose the authors to review methods and the updates;

- 2. Guide them through study selection and data extraction and
- 3. Guide authors through data entry, analysis, writing of results and discussion.

The course consisted of 30 minute formal lecture sessions interspersed with practical sessions. Participants were in touch with their co authors, mentors and the editorial bases of their respective review groups for much needed pre-editorial input. Timelines were also agreed upon, for submission of reviews for peer reviewing, in time for publication in the latest version of the Cochrane library. On completion of the course, participants were awarded certificates.

Exploring New Territory – Diagnostic Test Accuracy Workshop

Making an accurate diagnosis is the first step to solving any health problem. Once the diagnosis is right, the chances are high that an effective intervention or treatment can be provided for that problem.

Diagnosing a number of health problems today relies on the use of diagnostic tests or kits. The accuracy of these tests will determine whether people with a health problem are properly diagnosed and treated or not. It therefore becomes needful to assess the accuracy of various tests.

Diagnostic Test Accuracy (DTA) Reviews are an unexplored area in Nigeria. The Nigeria Branch of the South African Cochrane Centre has desired to develop reviews in this area. Our opportunity to begin acquiring knowledge in this area came when Ms Chioma Oringanje was invited to attend a DTA Workshop in South Africa. On her return, the Branch organized a one-day workshop on 17th August 2010, during which she passed on the knowledge she had gained to twelve participants. The participants were composed of medical doctors, medical laboratory scientists and a public health practitioner.

Ms Oringanje who facilitated the workshop made a number of presentations. She gave a brief overview of Diagnostic Test Reviews and also taught the participants how to formulate a DTA title, develop the protocol and the study design required for DTA reviews.

Participants were encouraged to develop DTA review titles but were also made to understand that there is currently a hold on the registration of new titles pending completion of those already registered. Though the statistical aspect of the review process appeared a bit complicated, participants were still keen on conducting DTA reviews in areas that border on tropical and neglected diseases. It was agreed that training on DTA reviews should be continuous with further explanations on the statistical analysis.

The workshop is expected to set the ball rolling with regard to the writing of DTA reviews.
